ROLES AND RESPONSIBILITIES OF DELEGATES AND ALTERNATES

The Delegates and Alternates who are elected to the District’s Annual Membership Convention will:

- **set policy direction for the District,**
- **enact resolutions,**
- **receive reports,**
- **adopt rules,**
- **review the annual budget, and**
- **amend the District By-Laws.**

INSTRUCTIONS FOR DELEGATE NOMINATION PETITIONS

1. Select a nominee. You may nominate yourself.
2. Get the correct number of signatures on the enclosed "Nomination Petition Form". (See Election Rules # 1 below for the required number of signatures).
3. Encourage the nominee to sign the petition saying that he/she is willing to be a candidate. (Bylaws require a written acceptance to appear on the ballot)
4. Mail the petition to the Election Board in the enclosed envelope.
Remember to put postage on the envelope.
5. **Be sure the petition gets to the PO Box by noon on Wednesday July 8, 2009.**
6. **DO NOT** mail or bring the petition to the Union office. We can only count the petitions sent to the Election Board at the PO Box – SEIU Healthcare District 1199WI, PO Box 250, Waunakee, Wisconsin 53597.

If nominations exceed allotted seats for Delegates/Alternates an election will be necessary. Instructions for voting will be sent with the secret ballots and will be mailed to your home after the nomination process is finished.

ELECTION RULES

1. Nominations for a Chapter's Delegate or Alternate require one (1) signature of a member of the Chapter in good standing [Article XI, Section 4, B, 4.].
2. All signers must be members of the District for at least 2 weeks prior to Wednesday July 8, 2009
3. Nominees for Delegate and Alternate to the District's Membership Convention must be members for at least 2 weeks prior to Wednesday July 8, 2009
